## **PSPNet: Self-Guided PSP Wellbeing Course**

#### **54 CE credits**

This self-guided course provides free education and guidance on effective skills for managing various mental health concerns, such as depression, anxiety and post-traumatic stress injuries. This course was designed to be helpful to Public Safety Personnel (PSP), who have mental health concerns and are looking for a new way to access services or are faced with barriers for accessing care. The Self-Guided PSP Wellbeing course is an internet-delivered cognitive behaviour therapy (ICBT) program. ICBT involves using the internet to deliver the same treatment content that is normally covered in face-to-face cognitive behaviour therapy (CBT) for depression, anxiety or post-traumatic stress injuries.

## **Covenant Health Palliative Institute: PalliPro Course**

### 9 CE credits

PalliPro is an educational series for all Alberta health care professionals and disciplines to strengthen knowledge, skills and attitudes in providing palliative care. PalliPro can be used by individuals for professional development or by groups to explore the interdisciplinary nature of palliative care. This free online education includes interactive components and scenario-based learning.

## Mental Health Structural Stigma in Healthcare; E-Learning Course

### **6 CE credits**

Those experiencing mental health and substance use (MHSU) concerns face stigma in every aspect of their lives. No matter the context, be it personal or professional, such individuals are treated differently. Unfortunately, they also find this same kind of stigma from the health-care system, which should be a place of care and understanding that helps them access the resources and support they need to maintain good health and manage their desired wellness.

This course is intended for health system leaders and influencers, as well as any healthcare professional, who want to better understand and identify structural stigma in their organization and how it contributes to inequity and poorer experiences and health outcomes for those experiencing mental health and substance use concerns.

## **Talking About Suicide**

### 12 CE credits

By the end of this course, you will have the knowledge, skills, and confidence to build trust with clients at risk of suicide, engage in meaningful conversations about suicide, assess risk factors, implement safety planning best practices, and provide appropriate support. You will return to your healthcare setting with a greater understanding of the complexity of suicide in Canada and recognize the shared responsibility of healthcare providers in both addressing suicide and instilling hope in clients



## U of A Lifelong Learning; Heart Failure Disease Care Path Integration 6 CE credits

Heart Failure (HF) is a complex syndrome and a major public health problem. Recent (2021) updates in the Canadian Cardiovascular Society guidelines for the management of HF define a new standard of pharmacologic care for HF with reduced Ejection Fraction (HFrEF) that incorporates 4 key therapeutic drug classes as standard therapy for most patients.

These foundational Guideline Directed Medical Therapies (GDMT) will be reviewed in addition to secondary therapies to improve outcomes in patients with HFrEF. Furthermore, recent evidence for Sodium-Glucose Cotransporter-2 Inhibitors (SGLT2i) for HF patients with preserved ejection fraction (HFpEF), regardless of the presence or absence of diabetes, will be presented. HF diagnosis, pathophysiology, and treatment options will also be reviewed. This free accredited eLearning course provides an overview of Care Paths in Connect Care and details the HF-specific Care Path, identifying benefits and clinical decision supports.

# <u>Alberta Health Services: Suicide Prevention, Risk Assessment & Management</u> (SPRAM)

### **18 CE Credits**

#### Available to AHS and non-AHS Employees:

Suicide Prevention, Risk Assessment & Management (SPRAM) is an eLearning series that responds to the foundational learning needs of health care providers, particularly those working in Addiction and Mental Health (AMH). The content supports developing foundational competence in suicide prevention, risk assessment, and managing individuals at-risk for suicide. The learner can use this content in a manner that is relevant to their practice domain and is intended to complement rather than replace any existing suicide prevention training.

## **Opioid Response & Management Training Program**

This is a free online training program, offered in collaboration with the Paramedic Association of Canada (PAC), Premergency Inc & the Canadian Standards Association (CSA). "The Opioid Response & Management (ORM) training program is designed to empower and support **Paramedic Service Organizations** and **Community First Responders** to build an efficient Model of Care to identify and respond to opioid-related emergencies" There are 3 program options:

The College is excited to announce the launch of a new course in our Learning Management System (LMS). The LMS was introduced to provide free Continuing Competence opportunities to all members and enhance training courses wherever possible. There are currently two live courses. The first, Regulatory Knowledge, was converted into a full course and launched in the LMS in October 2024. The course explores the legislation that governs paramedic practice in Alberta, the Standards of Practice and Code of Ethics that paramedics must adhere to and the role of the Alberta College of Paramedics. The course consists of six parts and a final exam.

Members can now also access a second course, Pain Management: Methoxyflurane (Penthrox®). The course is purposefully comprehensive in scope, offering methoxyflurane as a new pain management medication for paramedics in Alberta. The course consists of six parts and a final exam.

17 - 19 Hours = 57 CE credits



Although there is a fee for most completion certificates, the College will accept a screenshot of the member's Coursera account dashboard that shows course completion.

Set up an account on this website, then take the course. You can purchase a certificate at the end if you wish, but you don't have to. Once you have your account set up and have finished the course, take a screenshot from your dashboard that shows you completed the course. Save that screenshot as your proof and keep it for up to 5 years in case of an audit.

### To enter the course and get the CE credits:

In the search bar, type the word 'University'. You can then choose the correct listing based on the number of hours of your program:



Any of the courses through any University or College that are relevant to your practice can be claimed for CE credits. Here are a few examples:
